# **APPENDIX TO BULLETIN #3**

Following the release of Bulletin No. 3, some clubs sought further details or clarification with regard to some areas of information contained in the Bulletin. These details would have been important for those clubs when considering their provisional entries.

The PADBF Executive Committee have decided to make or clarify some changes, as follows:

# ENTRY CONDITIONS

This event is a Small Boat Championship only.

Classes may be combined in the early rounds of the competition but the Grand Finals will be separate. Each PADBF member may sanction an unlimited number of clubs in each Competition Class with **no restrictions on the** number of entries per club.

All entries must be sanctioned by the relevant governing PADBF member.

Cross rostering between Divisions is discouraged. In the case of "back to back" races, the Officials will NOT delay races for racers to transfer between crews (including steerspersons, drummers or paddlers).

# **Membership Requirements**

A racer may only represent one Dragon Boat Club. A racer must have been a bona fide member of the Dragon Boat Club that they represent at the PACCC for at least six (6) months before the PACCC in question. A bona fide member is one that has regularly trained/competed for the Club that they represent during the minimum period of six months.

#### **Crew Numbers:**

The maximum number in a Small Boat Crew is 14 (including 2 reserves). A full boat crew would be 12 including Drummer and Helm. The minimum number of paddlers in a Small Boat is 8.

### **Mixed Crew Requirements:**

Small Boat Combination: The Mixed crew must consist of a minimum of 4 to a maximum of 5 paddlers of either gender. Drummer and helm can be of either gender.

**Small boat** The following table shows the possible combinations of crews:

5 male paddlers / 5 female paddlers	+ drummer and helm of either gender
5 male paddlers / 4 female paddlers	+ drummer and helm of either gender
4 male paddlers / 5 female paddlers	+ drummer and helm of either gender
4 male paddlers / 4 female paddlers	+ drummer and helm of either gender

# **Technical Regulations and Championship Regulations:**

For the PACCC 2023, Edition 8.1 (January 24, 2020) IDBF Rules of Racing will be applicable and Edition 8 (January 1, 2020) of the Competition Regulations will be applicable. Crew Managers are advised to have a personal copy with them at the event and to ensure that their crews are conversant with these rules in conjunction with the information provided in the Bulletins.
